That the Society shall be called the Ossianic Society, and that its object shall be the publication of Irish Manuscripts relating to the Fenian period of our history, and other historical documents, with literal translations and notes. 2. That the management of the Society shall be vested in a President, Vice-presidents, and Council, each of whom must necessarily be an Irish scholar. The President, Vice-presidents, and Council of the Society shall be elected annually by the members, at a General Meeting, to be held on the Seventeenth Day of March, the Anniversary of the Society, or on the following Monday, in case St. Patrick's Day shall fall on a Sunday. Notice of such meeting being given by public advertisement inviting all the members to attend. 3. That the President and Council shall have power to elect a Treasurer and Secretary from the Members of the Council. 4. The receipts and disbursements of the Society shall be audited annually by two Auditors, elected by the Council; and the Auditors Report shall be published and distributed among the members. 5. In the absence of the President or Vice-President, the Members of Council present shall be at liberty to appoint a Chairman, who will not thereby lose his right to vote. Three members of the Council to form a quorum. 6. The funds of the Society shall be disbursed in payment of expenses incident to discharging the liabilities of the Society, especially in the publication department, and no avoidable expenses shall be incurred. 7. Every member shall be entitled to receive One Copy of the Society...
